BANCO NACIONAL DE DESENVOLVIMENTO ECONOMICO E SOCIAL – BNDES, a wholly-owned federal government company, with headquarters in Brasilia, the Federal Capital, and services in the City of Rio de Janeiro – RJ, at Av. República do Chile, no. 100, registered with the CNPJ – Brazilian Registry of Legal Entities under no. 33.657.248/0001-89, hereinafter simply referred to as **BNDES**, represented herein in accordance with its corporate bylaws, and **BUREAU VAN DIJK EDITIONS ELECTRONIQUES SA (BUREAU VAN DIJK ELETRONIC PUBLISHING LTD)**, with headquarters in Geneva, Switzerland, registered with Federal ID, under no. CH-660-1044991-1, hereinafter simply referred to as **CONTRACTOR**, represented herein in accordance with its articles of incorporation, as authorized on IP AC/DECRE/GECRE1 no. 03/2017, of 18/01/2017, according to the budget forecasting in items 1800100001 (ATI), 3101700021 (ATI), 3101700040 (ATI), 3102200020 (AC) and 3101700023 (AP), based on article 65, II, of Law no. 8.666/93, firm this Second Amendment to Agreement OCS no. 129/2014, and have between themselves agreed as follows in the Clauses below:

CLAUSE ONE – PURPOSE

The following Document has as purpose the qualitative modification of **OCS AGREEMENT N. 129/2014**, in order to replace the Bankscope database with Orbis Bank Focus, maintaining unchanged all the other contractual conditions.

Sole Paragraph

Due to the change above mentioned, where is written Bankscope database must be read, from now on, Orbis Bank Focus, both in the Agreement and its Annexes.

SECOND CLAUSE – RATIFICATION

Remain in forced and unchanged all other Agreement's Clauses, do not constituting this Contractual Document waiver or novation.

The pages of this Document are initialed by Moreno Castilho Pereira Peralles, a **BNDES** lawyer, as authorized by the legal representatives that sign it.

This Document is issued with a text in Portuguese and a text in English, each with 2 (two) copies, each copy considered as the original instrument, and both texts, jointly, constituting one and the same instrument. In the event of different interpretations, the text in Portuguese shall prevail for interpretation purpose of the Amendment herein.




